In signing this document, I/we represent that I/we am/are fully knowledgeable and aware of the danger and hazards associated with riding bicycles. I certify that I have the necessary skill and am competent to ride a bicycle in a safe manner, and the bicycle is in a safe operating condition. I will be riding on public roads and am solely responsible to determine the manner and speed of my bicycle while riding during the entire duration of the pilgrimage.

For and in consideration of the Committee's agreement to allow me / the minor I am signing for and my passenger (where/if applicable) to participate in the bicycle pilgrimage - the receipt and sufficiency of which is acknowledged by my signature hereon - I assume the risk of all bodily injuries, including death, resulting therefrom, and personal injuries to me and damage to and loss of my property and any other indirect or consequential damages, resulting directly or indirectly, wholly or in part, from my participation in the Event and while travelling to and from the Event and consequently, I freely, on behalf of myself, my heirs and estate, fully, finally and forever release and hold harmless *Ghaqda Pellegrinagg Muturi u Roti*, each member of the committee – whether in his/her capacity as well as personally - its members, volunteers, sponsors, agents, representatives and any successors, amongst others, associated with any and all ride events from any and all liability, claims for loss of life and/or property and/or damages - whether direct or indirect - and demand suits - including all legal fees - which may arise from my activity of riding my bicycle during the pilgrimage.

I also hold harmless and exempt from any responsibility whatsoever *Ghaqda Pellegrinagg Muturi u Roti Zabbar* and it's Committee Members for any damage or loss of/to my property – namely my bicycle - during the transportation from Zabbar to Rabat (Malta) should I opt to benefit from the transportation service offered.

I hereby agree, for myself and/or for my passenger/ participant minor under the age of eighteen for whom I am signing, to indemnify, defend, and hold *Ghaqda Pellegrinagg Muturi u Roti* named above and its Committee members, volunteer, helps and any third parties involved in the organisation of the event, harmless from and against any and all claims, liabilities, losses and damages, costs, expenses (including attorney's fees) judgments and penalties arising out of any of my, and/or said minor's acts or omissions to act.

I also certify that I / the minor I am signing for am/is physically fit and have no known physical or mental impairment that may affect my/his/her safety, that of my passenger (2<sup>nd</sup> cyclist, if applicable) or the safety of the group and/or the general public and that I am 18 years old or older. I understand that the responsibility and choice of wearing a helmet or other protective gear is solely my own. I certify and declare that I am not under the influence of any narcotic, alcohol, or other drug/medicine - whether prescribed or otherwise - that may impair my understanding or judgment and that I will not at any time during the entire event ride my bicycle under the influence of any drug or alcohol. I also understand that this Waiver and Release is in force for the duration of the ride and covers any and all activities and further acknowledge that this Accident Waiver and Release of Liability Form will be used by the event organisers/the Committee and that such will govern my actions and responsibilities for the duration of the entire bicycle pilgrimage.

All the above applies in an equal manner to any passenger, minor under 18 years of age for who the parent /legal guardian is signing and/or 2<sup>nd</sup> cyclist signed hereunder.

Permission for participation is subject to the Committee's approval, which approval remains subject to the Committees' absolute and complete discretion. The Committee reserves the right to deny participation or to stop any participant – through any Committee Member - from continuing to participate at any time as it may deem fit.
