In signing this document, I/we hereby authorize the above mentioned minor of who I/we am/are the parent/s or Legal Guardian/s and represent that I/we am/are fully knowledgeable and aware of the danger and hazards associated with riding bicycles. I/we certify that my/our son/daughter/ minor under my/our guardianship has the necessary skill and competence to ride a bicycle in a safe manner, and the bicycle is in a safe operating condition. I/we am/are fully aware that such minor will be riding on public roads and I/we assume full responsibility of the safety, well being and behaviour of such minor.

For and in consideration of the Committee's agreement to allow son/daughter/ minor under my guardianship to participate in the bicycle pilgrimage - the receipt and sufficiency of which is acknowledged by my signature hereon - I/we assume the risk of all bodily injuries, including death, resulting therefrom, and personal injuries to the said minor and any damage to and loss of the minor's property and any other indirect or consequential damages, resulting directly or indirectly, wholly or in part, from said minor's participation in the Event and consequently, I/we freely, on behalf of the said minor and myself/ourselves as parents/legal guardians, the minor heirs and estate, fully, finally and forever release and hold harmless *Għaqda Pellegrinagg Muturi u Roti*, each member of the committee - whether in his/her capacity as well as personally - its members, volunteers, sponsors, agents, representatives and any successors, amongst others, associated with any and all ride events from any and all liability, claims for loss of life and/or property and/or damages - whether direct or indirect - and demand suits - including all legal fees - which may arise from my activity of riding my bicycle during the pilgrimage.

I/we hereby agree for and on behalf of participant minor under the age of thirteen - who I/we am/are authorising and giving my/our consent for participation by signing this document - to indemnify, defend, and hold *Ghaqda Pellegrinagg Muturi u Roti, Zabbar* named above, harmless from and against any and all claims, liabilities, losses and damages, costs, expenses (including attorney's fees) judgments and penalties arising out of any of my, and/or said minor's acts or omissions to act.

I also certify that the participating minor is physically fit and have no known physical or mental impairment that may affect his/her safety or the safety of the group and/or the general public and that I/we ( the parents/legal guardian/s) am/are 18 years old or older. I understand that the responsibility and choice of / providing a helmet or other protective gear for the participating minor is solely my own. I certify and declare that the participating minor is not under the influence of any medicine, narcotic, alcohol, or other drug - whether prescribed or otherwise - that may impair the said minor's understanding, judgment or diminish the necessary skills. I also understand that this Waiver and Release is in force for the duration of the ride and covers any and all activities and further acknowledge that this Accident Waiver and Release of Liability Form will be used by the event organisers and that such will govern the actions and responsibilities of the participating minor I/we am/are signing for, for the duration of the entire bicycle pilgrimage.

Permission for participation is subject to the Committee's approval, which approval remains subject to the Committees' absolute and complete discretion. The Committee reserves the right to deny participation or to stop any participant – through any Committee Member - from continuing to participate at any time as it may deem fit.
